Background



COFA Islander Programs

Compact of Free Association

- The Compact of Free Association (COFA) is an economic and military treaty between the United States and the Republic of the Marshall Islands, the Federated States of Micronesia, and the Republic of Palau.
 - Individuals from these nations can come and go freely from the United States without work permits or visas.
 - ► Many COFA islanders reside in King, Spokane, Pierce, and Clark counties.



COFA Islander programs

- COFA Islander Health Care was established through 2018 state legislation. COFA Islander Dental Care was established the following year for the 2021 plan year.
- These programs provide premium payment and cost-sharing assistance for COFA islanders living in Washington, enrolled in a Qualified Health Plan (QHP) or Qualified Dental Plan (QDP).
 - ► HCA pays the monthly premiums directly to the carriers.
 - A debit card is provided to pay for out-of-pocket costs.





Transition to Apple Health

COFA Islander programs transition

- Individuals under the age of 65 and without Medicare who were enrolled in COFA Islander programs as of June 2021 transitioned to Apple Health for Adults on July 1.
- Individuals aged 65 and older or those with Medicare, remained enrolled in COFA Islander programs from July 1st through the end of 2021. This provided time to apply for Apple Health with the Department of Social and Health Services (DSHS).

You may be eligible for Apple Health (Medicaid). You must apply with the Department of Social and Health Services (DSHS).

Who may still be eligible?

- COFA Islander Health Care and COFA Islander Dental Care is still available for COFA islanders who are:
 - Over resources for Classic Apple Health.
 - Approved for a spenddown but have not met their spenddown amount.
 - Entering the U.S. with another status such as permanent resident, spouse of a U.S. citizen.



Outreach efforts

GovDelivery for intentional and consistent messaging.

- Developing and translating informational materials in the six main COFA languages.

Apple Health overview





Apple Health overview

- Apple Health provides care to over 2 million Washington residents, including pregnant individuals, children, elderly and adults ages 19-64.
- Apple Health provides medical, vision, dental benefits and health care services such as preventative care, cancer screenings, treatment for diabetes and high blood pressure, and many other health care services.
- There are no co-payments, deductibles, and other out-of-pocket expenses.





Apple Health eligibility

- An application is required to determine if an individual is eligible for Apple Health.
 - Most individuals eligible for Apple Health (Medicaid) apply for coverage online at <u>wahealthplanfinder.org</u>.
 - COFA islanders must meet all eligibility criteria for Apple Health, including income limits, Social Security Number (SSN) requirements and Washington residency.
 - Income verification may be required before eligibility for Apple Health is determined.
 If proof of income is required, individuals will receive a notice with the request.

Classic Apple Health

Classic Apple Health refers to programs administered by the Department of Social and Health Services (DSHS).

- Individuals who are age 65 years or older, have blindness or a disability, or need Long-Term Services and Supports (LTSS), apply for Apple Health coverage online at <u>washingtonconnection.org</u>, call DSHS or submit a paper application.
- Eligibility criteria varies for each program and is based on household size, income, and resources.





Classic Apple Health programs and services

- There are many Classic Apple Health programs and services available to eligible individuals, including:
 - Apple Health for Workers with Disabilities (HWD) allows enrollees to earn and save more money and to purchase health care coverage with monthly premium based on a sliding scale.
 - Medicare Savings Programs (MSP) helps eligible individuals by paying Medicare premiums, deductibles and other Medicare-related costs.
 - Tailored Support for Older Adults (TSOA) provides services to support unpaid caregivers and provides a small personal care benefit to people who don't have an unpaid family caregiver to help them.
 - Medicaid Alternative Care (MAC) provides services to unpaid caregivers designed to assist them in providing quality care to family members while also improving their own well-being.

Apple Health next steps

Individuals enrolled in Apple Health will:

- Receive a ProviderOne Services card.
 - If a COFA islander had Apple Health in the past, it is still valid. They will not receive a new card.
- Enroll in a plan with a Managed Care Organization (MCO).


Managed care enrollment




Individuals should take their health plan ID card when they go to a doctor, pharmacy or other health care provider.

Change of circumstances

Individuals approved for Apple Health are required to report the following changes within 30 days:

- Residential or mailing address
- Marital status
- Family members or dependents moving in or out of the residence
- Pregnancy

- Health insurance coverage
- Immigration or citizenship status
- Income of more than \$150 that is expected to last longer than 60 days
- Tax filing status



Retroactive Apple Health

- Retroactive coverage is not automatic and must be requested. Individuals must meet all eligibility requirements for the months requested.
- The retro request is approved when the individual:
 - Requested retro during the time specified.
 - Would have been eligible for Apple Health for any or all three months if they had applied during that period.
 - Received medical services in the months requested.




Apple Health renewal

- Most Apple Health programs require renewal of eligibility at least every twelve months. Some exceptions include pregnancy medical and medically needy spenddowns.
- Individuals can renew their MAGI Apple Health coverage 60 days before their certification period ends.
- If a renewal is not received, a termination notice is sent 20 days before the end of the certification period.
- Apple Health will be restored without a gap in coverage when an eligible individual submits a completed renewal within 90 days after coverage closes.







Transition to Apple Health (Medicaid)

The Health Care Authority (HCA) is working with state and federal partners to plan the transition of COFA Islander programs to Apple Health coverage for individuals from the Federated States of Micronesia, the Republic of Palau, and the Republic of the Marshall Islands.



COFA islanders seeking coverage now should continue applying for COFA Islander programs through <u>Washington</u> <u>Healthplanfinder</u> I until the transition is complete.
